DISCLOSURE QUESTIONNAIRE CATEGORY	Environmentally Intensive Industries
TOPIC	Energy and Emissions Intensive Industries
SUMMARY OF ISSUE	As a manufacturing company for custom hair care products, Prose's products are energy and emissions intensive. The primary energy sources are natural gas and electricity. Additionally, the company receives raw material and supplies through air freight (5%) and ground freight (95%). Finally, the company relies on fossil fuels for the delivery of products to customers.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	100% of Prose's revenue comes from energy-intensive products, produced through a manufacturing process at their facilities.
IMPACT ON STAKEHOLDERS	Operating in a energy and emissions intensive manufacturing industry, this can pose risks to stakeholders. The manufacturing process consumes natural gas and electricity. Emissions are released from the transportation of raw materials and finished products.
IMPLEMENTED MGT PRACTICES	Prose measures carbon emissions on an annual basis and has done so since 2019, one year after the company was founded. As part of the company's Climate Neutral Certification, the company offsets all emissions through strategic investments in energy and forestry with key investments in sub-Saharan Africa as well as Latin America to mitigate carbon for those populations disproportionately affected by climate change. Additionally, the company has a reduction action plan (RAP) through Climate Neutral Certification, which allows the company to zero in on high emissions areas and look to reduce them. These include supply chain localization projects, ingredient refinement to decrease emissions, or behavioral/education initiatives to include consumer action. Prose reduced emissions per revenue 47% from 2020 to 2021. The company's target is to decrease emissions per revenue as stated on the company goals in 2022. The company has a facility in New York where rainwater is collected and solar panels are in use. The main corporate office is LEED Certified. The company's office in France is within a green zone where 100% of the employees are commuting to work without the use of a car. The Sustainability Team is managed by the VP of Social Impact and works cross-functionally with internal teams to emphasize best practices as well as internal aggregators for innovative ways to reduce emissions. Some examples are revamping packaging to more sustainable options, limiting the use of Air Freight, and sourcing ingredients and taking emissions into consideration.

TOPIC	Water Intensive Industries
SUMMARY OF ISSUE	Prose is a manufacturing company that utilizes water in all of its products. The company sells hair products (shampoo, conditioner, mask, leave-in conditioner, and curl cream) that are 60%-80% water by formulation.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	100% of revenue comes from selling products that the company manufactures and uses water within the products.
IMPACT ON STAKEHOLDERS	Operating in a water intensive manufacturing industry, this can pose risks such as water stress or depletion of local water sources if water use is not appropriately managed. Prose's manufacturing facility is based in Brooklyn, NY, which has a Medium-High water risk, according to the World Resources Institute. New York City's Department of Environmental Protection declared a Drought Emergency most recently in April 2002, with normal conditions being restored in January 2003.
IMPLEMENTED MGT PRACTICES	Prose has not determined its water intensity (such as gallons per unit of product). However, a Life Cycle Assessment is being conducted in 2023 with a focus on water impact. The Life Cycle Assessment will focus on water consumption, marine eutrophication, marine ecotoxicity, and freshwater ecotoxicity. Prose will use the information from the Life Cycle Assessment to set Key Performance Indicators.
MANAGEMENT COMMENTS	Prose is actively working on getting key climate legislation passed.
