This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	The company had a terminated employee in 2018 who sought damages with claims that the company did not pay the correct amount of overtime.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Damages sought were over \$100,000. The company used Worker Compensation Insurance to deal with the situation and paid the \$5,000.00 deductibles. The case settled in mediation for approximately \$28,000.00, which was the equivalent of less than 2% of the company's revenue that year.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for the complainant employee.
IMPLEMENTED MGT PRACTICES	"The company's IT support service is a 24/7/365 affair. The company has invested considerable time and money in improving scheduling coordination (to avoid overtime challenges). They started using a time tracking system, reported by each employee individually and administered by a third party, who ensures compliance. They also improved overtime/after-hours compensation and adding staffs to avoid pressure on workers who need to ""always be on""."
RESOLUTION	The case was resolved by settlement in mediation for approximately \$28,000.00.
