Summary of Issue	Kueponi Consultoría is a management consultant that has had clients in the Alcohol, Bottled water companies, Fossil fuels(coal, oil sands), Industries at Risk of Human Rights Violations, Marketing of breast milk substitutes, Pharmaceuticals, Volunteer Placement in Orphanages industry. The nature of the company's services with clients in these industries has been related to management and sustainability consultancy, all services can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The revenue from clients operating in the alcohol industry represented 1.2% in FY23-24. The revenue from clients operating in the bottled water industry represented 1.2% in FY23-24. The revenue from clients operating in the industries at risk of human rights violations represented 15% in FY23-24. The revenue from clients operating in the marketing of breast milk substitutes industry represented 3% in FY23-24. The revenue from clients operating in the pharmaceuticals industry represented 3.35% in FY23-24. The revenue from clients operating in the Volunteer Placement in Orphanages industry represented 1.2% in FY22-23. The revenue from clients operating in the Fossil fuels - coal, oil sands industry represented 4% in FY23-24.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company does not work with clients in the following industries: Pornography, Tobacco, Prisons, Weapons, Gambling and Lotteries, Mining, Defense, Zoos and aquariums,

	Cannabis-related products, Nuclear energy, Short-term or high-interest loans, Illegal products.
	The company has due diligence in place as the service to ensure that the services provided by the company are not used for harming people and the environment as the solution they provide are improving their client's sustainability practices. The company has a process where they do background checks through public and private databases, analyze the potential customer's corporate structure, including identifying all related entities, subsidiaries, and major shareholders, and conduct reputation and compliance reviews.
