Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Possible Penalty Related to Anti-Competitive Practices
Summary of Issue	Investigation by the Autorité de la concurrence (ADLC), which is the French Competition Authority, following a complaint filed in 2019 by a competitor, alleging, among other things, anti-competitive practices in the online appointment scheduling and teleconsultation markets. Following the filing of this complaint, on May 18, 2021, the ADLC carried out an inspection and seizure operation at the Group's premises. ADLC's investigation is still ongoing.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	As the case is currently pending, the financial impact is yet to be determined.
Impact on Stakeholders	The potential impact related to the case is the financial impact on competitors and consumers.
Resolution	The case is pending resolution.
Implemented Management Practices	In March 2022, Doctolib recruited a lawyer specialized in competition law issues - his scope of intervention covers the activities of the entire Group. In November 2022, it also created an internal code of conduct, one section of which covers best practice in competition law.
Management Comments	Doctolib follows best standards regarding management of legal risks. All employees also sign a code of conduct, covering competition practices.
