



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	H.B. Evelyn - Hattiers Rum is a retail company that earns a material amount of revenue from the sale of alcohol

IMPACT ON STAKEHOLDER(S)	Alcohol may have a negative impact on the health and well-being of individuals and their communities
IMPLEMENTED MGT PRACTICES	H.B. Evelyn - Hattiers Rum complies strictly with all relevant tax regulations and laws for the sale of alcohol. The company currently supplies the UK only, and is registered with the local government as a food business, HMRC (tax authority) under the various schemes for the blending of rum, the AWRS (Alcohol Wholesale Registration Scheme), Personal and Premises License to sell alcohol to both the trade and direct to consumers. H.B. Evelyn - Hattiers Rum insures that any direct to consumer orders are received by the purchaser who is over 18 (the legal age to consume alcohol in the UK), by only working with one fulfillment partner, Royal Mail and send this as a restricted item. Whenever the company sells or serves alcohol in person at events, it is a legal and our ethical requirement to ensure that the person is not over the limit. Bottles of alcohol produced are labelled with a notice asking consumers to drink responsibly and provides a link to DRINKAWARE.co.uk for further health information. Drinkaware is an independent charity working to promote and help people making better choices about drinking and reducing alcohol misuse and harm in the UK. In addition, Hattiers Rum includes in its label a logo which recommends women to not drink alcoholic beverages during pregnancy due to the risk of birth defects.
