



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	In the last five years 39 cases of individual litigation were brought against the company pertaining employee issues such as unfair dismissal and labour protections.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	<p>The number of employees that brought forth the litigations represent ~3% of company's employees.</p> <p>All of these lawsuits have been settled out of court with a cumulative settlement amount of 70,475,423 Chilean Pesos.</p>
RESOLUTION	None of these litigation cases resulted in a verdict against company and were instead settled out of court. BancoEstado Microempresas S.A., has never had enforceable judgments against it for the violation of fundamental rights of its workers, nor any fines for such reasons.
IMPLEMENTED MGT PRACTICES	<p>At a preventive level, within the framework of the Leadership program, tools are delivered to the leadership and follow ups are made, to support their management of the workers.</p> <p>On the other hand, workers with low performance are provided a work plan and support that allows them the opportunity to reverse the results, and avoid termination.</p> <p>When, despite having made all the previous instances, a termination request is received from managers, the company reviews all the employment records to assess the termination, and it goes through an approval process internally.</p>
