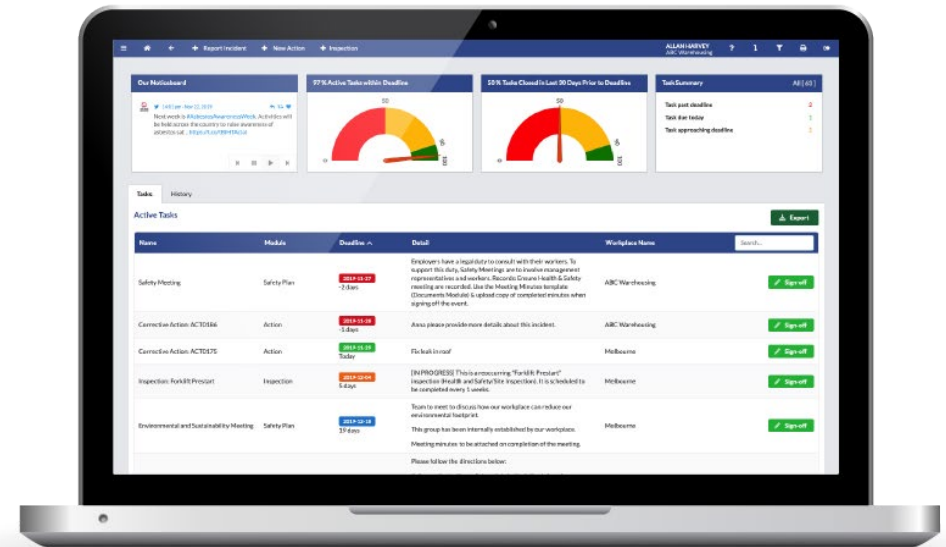

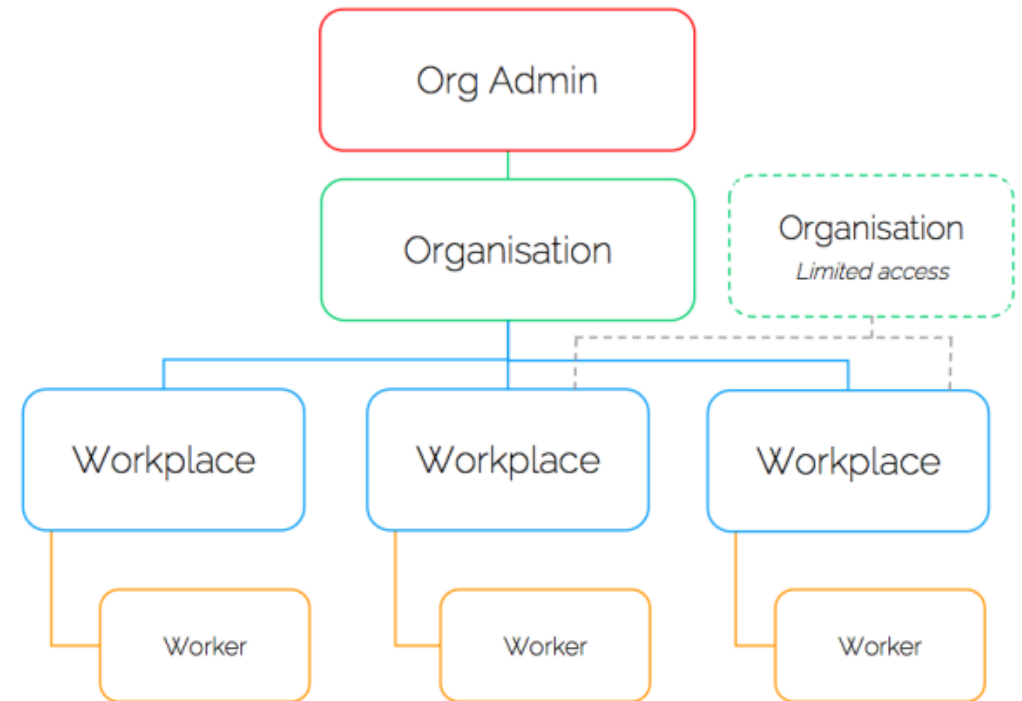
# Our unique system architecture

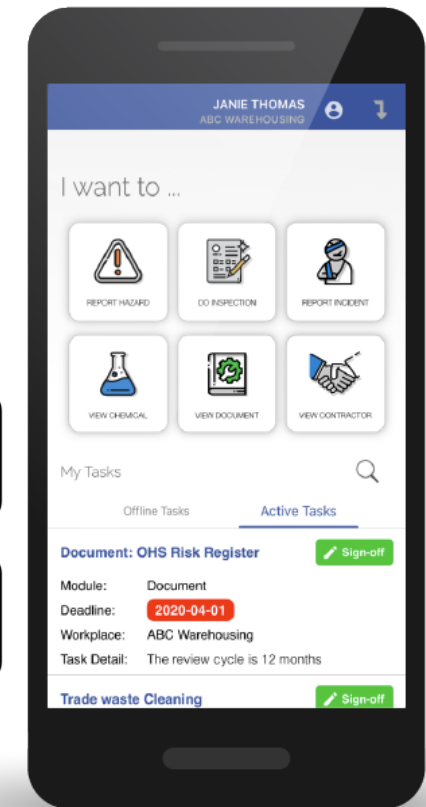
# Our Apps

- ✓ Simple interface – anyone can use!

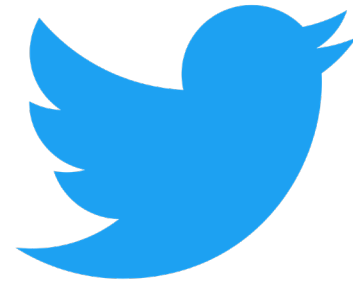

# Safety Planning & Compliance Module

---

This module allows you to manage all recurring safety management and compliance tasks within your safety management system. These include; preventative maintenance (i.e. plant and/or equipment scheduled maintenance, electrical testing and tagging, emergency management schedules for fire equipment, etc.), meeting schedules (i.e. safety committee), PPE expiry, annual emergency trail evacuation planning, and more.

# Corrective Action & Hazard Module

- Available on both iOS and Android apps for mobile use



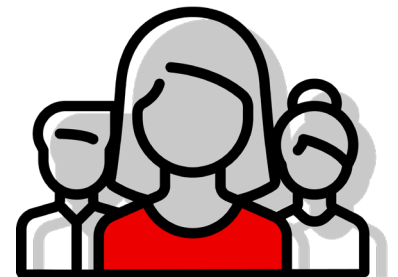
# HR Module & Workers Compensation Records

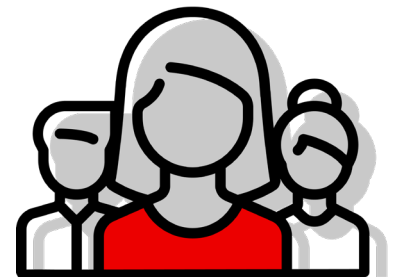
# Training Expiry Management Module
