



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Case 1: Nova prepared a Property Condition Assessment report for a client, which stated the property was in generally good condition and some repairs were necessary. In 2016, the client claimed Nova did not exercise reasonable caution with their report, because an issue with the facade occurred at the property. Case 2: Similar to Case 1, the issue arose from a Property Condition Assessment written by Nova. The client alleged that Nova was negligent in conducting their assessment. Nova denied the claim but the case was settled in June 2020. Case 3: Similar to Cases 1 and 2, a claim was made that Nova was negligent related to Nova's warranty inspection of a roofing and coating company's installation on a property.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Case 1: The case was settled for 1.8% of company's revenue. Case 2: The case was settled for 1.3% of company's revenue. Case 3: The case was settled for 0.02% of company's revenue.
IMPACT ON STAKEHOLDERS	All cases had a financial impact on Nova's clients who were purchasing properties and relying on Nova's expertise in identifying issues in Property Condition Assessment reports.
RESOLUTION	Case 1: A jury found Nova to be at fault in 2018. Case 2: The matter resulted in settlement in 2020. Case 3: Nova took no admission of liability and the matter was settled.
IMPLEMENTED MGT PRACTICES	Nova has taken the following actions: performed internal training(s) for Nova's Account Managers [and other client facing employees] focusing on the legal topics of: debt versus equity scopes of work, limitation of liability, and reliance language. New policies/practices include enhancing the reliance letter templates and formalizing the process of providing reliance on their work product.
