



## DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

<b>SUMMARY OF ISSUE</b>	In the Project for the transfer of the Post-Communication Operation, which represented the largest share of disconnections, 171 factory workers and operations were terminated by the factory transfer from the Osasco (SP) plant to Pouso Alegre (MG). Previously, at the beginning of the joint operation with the Unilever sales force, in March 2018 the former sales force Mãe Terra replaced the sales representatives (PJ) with CLT workers because the Unilever model does not provide for the use of freelancers for commercial representation before customers. (CLT) 12 resources were maintained and reused at Unilever.
<b>SIZE/SCOPE OF ISSUE</b> (e.g. \$ financial implication, # of individuals affected)	171 employees were laid off, representing 77% of the company's workers.
<b>IMPACT ON STAKEHOLDER(S)</b>	171 employees laid off.
<b>IMPLEMENTED MGT PRACTICES</b>	<p>For employees terminated before July / 19, legal funds were guaranteed. For employees terminated after communication of the transfer of the Operation: a package was offered with 25% of the salary each year, 6 months medical assistance and food card for 6 months, technical training in new functions for employees (extending the benefit to their family members) and relocation assistance / consultancy.</p> <p>Before the restructuring process, the company guaranteed the legal funds of the dismissed workers</p>
