- Intentional misrepresentation of practices, policies, and/or claimed outcomes during the company's certification process

Summary of Issue	Inntel Group Limited is a travel company that has had clients in the Nuclear Power or Hazardous Materials & Whole life insurance products industry. The nature of the company's services with clients in these industries has been related to providing companies employees with safe, affordable and sustainable travel solutions, all services can be sold to both clients in controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The revenue from clients operating in the Whole life insurance products industry represented 5.9% in FY 22-23.  The revenue from clients operating in the Nuclear Power or Hazardous Materials industry represented 2.9% in FY 22-23.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.  B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company has a firm commitment to avoid working with clients from industries that pose serious ethical or environmental concerns.  The company evaluates new clients on a case by case basis, potential clients are asked to complete an Ideal Client Profile template and one of the questions is to check whether a client operates in a sensitive industry. If the company is from a sensitive industry, the client is referred to the Senior Leadership Team for consideration and discussion. For existing clients, the Client Relationship Manager checks M&A activity for their client prior to their annual business review as well as any diversification of core business purpose.  The company does not require their client to follow a code of conduct.
