## Disclosure Questionnaire Category: Other - Other Disclosure Practices

<b>Topic</b>	The company offers on-site clay pigeon shooting
<b>Summary of Issue</b>	Farncombe Estate is an integrated countryside estate led by three boutique hotels. The company offers many on-site activities to their clients, including clay pigeon shooting.
<b>Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)</b>	In FY22, 0.38% of the company's annual revenue was from clay pigeon shooting.
<b>Impact on Stakeholders</b>	Access to a firearm significantly increases the risks of violent outcomes, including suicide, homicide, serious injuries, and unintentional gunshot.
<b>Implemented Management Practices</b>	<p>All participants prior to shooting, have to sign the company's waiver. The company also makes an initial assessment of the guests and judges their ability as to whether they can take part in the activity, depending on safety guidelines. A safety brief is provided prior to shooting, and all guests are shown the correct stance and all the safety aspects of the guns. The guns are fitted to the guests prior to firing, to ensure that the correct stance and posture are maintained at all times. All loading and safety is undertaken by the instructor, and as soon as the guest has shot the gun, the instructor's hand will be on it to recover the gun and to reload it. At no stage is the guest left alone with the gun without an instructor present.</p> <p>The company holds the licence for all the shotguns that are used on the Estate, and it also holds the section 11( 6) application from Gloucestershire and West Mercia Police Forces to hold clay shooting on-site. All instructors hold their own Shotgun License as well.</p> <p>Farncombe Estate does not offer any other type of shooting activities on-site.</p>
<b>Management Comments</b>	We have written a comprehensive safe systems of work policy for the Clay shooting, and this also has attached a risk assessment covering all aspects of the sport and all the safety issues attached to it. All our Instructors have shotgun Licences



	<p>and all have undertaken a professional course and are qualified under Lantra to deliver Instruction safely at all times. The head of adventures oversees regular ongoing training with all our Instructors to ensure compliance with all of our activities.</p> <p>Moreover, the company has all the appropriate insurance in place with regard to their Public Liability coverage for clay pigeon shooting.</p>
