Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Iniciativa Agronegocios is a forestry company that operates in Mato Grosso do Sul in Brazil. They operate five different farms, all of which are 100% FSC certified. They exclusively grow eucalyptus trees.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The company operates 5000 hectares of land, 70% of which is cultivated for eucalyptus plantations. The rest of the land is set aside for native vegetation.
IMPACT ON STAKEHOLDER(S)	The company operates in the Cerrado Biome in Brazil, which is home to 5% of the world's biodiversity. The company only purchases previously degraded land as a result of intensive agricultural use that was converted prior to 1995 and only operates in areas of non-natural pasture. As part of the FSC Certification process, the company carried out a High Value Conservation study on the company farms through an independent third party and none of the company's farms are located in a high risk area of environmental concern.
IMPLEMENTED MGT PRACTICES	The company only operates small scale plantations and implements minimal cultivation to prevent soil erosion. They carry out an Analysis of Social and Environmental Risk of all pesticides used on their land. They continuously monitor the rate of pests and diseases, as well as study the effects of fertilisers, which allows the company to minimise the use of inputs. They have set a target to reduce the use of chemical fertiliser on their farms by 2.5% every year from a baseline year of when each farm was purchased.
	The company carries out flora and fauna measuring and monitoring through the use of camera traps. They use the Normalized Differentiation Vegetation Index (NDVI) to employ impact mitigation measures. They have created special flora and fauna corridors, banned hunting and fishing on their land and isolated preserved areas.
	The company also monitors the quality of their water both prior to and post operation, through procedures which are approved by the FSC. They conduct an analysis of the environmental and health risks before using any non-biological pesticides. They have also collaborated with the Agricultural School at the University of Sao Paulo (ESALQ-USP) on researching their fertiliser use and the impacts on their soil.
	Finally, the company carries out a study of High Conservation Value of their farms and the impacts on adjacent lands as well as studies on the impacts to local communities. They have carried out workshops with local community leaders and representatives to gather feedback around areas of improvement. They have implemented this feedback in the form of 10 different initiatives and have delivered one in the form of a social project for local children to develop their own potential and that of their community by learning about and engaging with the agricultural industry.
