Summary of Issue	Keiken Engineering is a company that offers services focused on water treatments and energy efficiency. The materials used in the development of their products and services include mined materials, such as: Pomez Stone, Zeolite, Sand, Anthracite and Active Carbon.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Approximately 40%% of the company's Cost of Goods Sold comes from mined materials.
Impact on Stakeholders	While companies involved in the mining industry play an important role in society and our economy by providing essential products, creating jobs in rural communities and stimulating economies across the globe, the mining industry also has several significant risks for negative social and environmental impacts. Some of these impacts are related to labor practices and worker health and safety; environmental impact of the materials being mined and the practices of the mining; community impacts regarding access and equity to natural resources and the broader impacts they have on an area.
Implemented Management Practices	Keiken Engineering has a code of conduct applicable and signed by all their supplier that establishes minimum expectations regarding social and environmental standards. The company also has a supplier policy for Conflict Minerals that lists tasks to be carried out by vendors and minimum expectations to ascertain that their goods are conflict-free. In addition to that, the company ask their suppliers to provide evidence of their good practices. Suppliers are required to provide Keiken with as much information as possible about the impact of their activities. Keiken sends an homologation document and audit form to suppliers involved in the mining sector where they are asked to provide certificates of quality, environmental management, occupational health.
