Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Category: Recalls

L-Acoustics Group reported conducting 0 mandatory and 19 voluntary recalls in the past five years, representing 5,21% of the company's products for the same period. When a product is recalled, various stakeholders such as customers, suppliers, investors, commercial partners, and local communities may face negative impacts, including health and safety risks, financial losses, loss of trust, damage to credibility, and other inconveniences. Disclosure Questionnaire Category: Prison Labor

The current B Corp Certification assesses a company's risk (potential negative impacts) separately from its positive impacts. B Lab's risk standards are additional minimum requirements that companies in controversial industries and/or practices must meet in order to be eligible for B Corp Certification under V1.6. Risk standards are a necessary method to maintain credibility, manage risk, and achieve the impact B Lab seeks in the world.

L-Acoustics is directly involved in the Prison Labor Industry; an industry which B Lab requires additional minimum standards. During this assessment, it was confirmed that L-Acoustics meets the minimum requirements for the Prison Labor as outlined in the [Guidance for Eligibility Concerns and Minimum Requirements under V1.6](#) link.

As part of the requirements, the L-Acoustics group, which involves its subsidiaries SIMEA and HGP, needs to publicly disclose its approach to government affairs, inclusive of lobbying/advocacy and political activities:

"L-Acoustics Group does not engage in any form of lobbying or policy advocacy that directly or indirectly support mass, or increasing rates of, incarceration or prevents reform attempts to reduce incarceration. The company does not have any material, justified, and unresolved complaints about product quality, product price, and/or work conditions for people in prisons."

Its public stance against mass, or increasing rates of, incarceration and other material issues related to the prison industry, approved by the highest level of governance within the company, and a commitment to making efforts towards collective action and/or engagement with stakeholders, focused on improving how people who are incarcerated are viewed and treated before, during, and after incarceration, can be found at: <https://www.l-acoustics.com/about-us/corporate-social-responsibility/>
