



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	As a construction and real estate developer, Haven Ventures operates in an industry that is energy and emissions intensive.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Approximately 98% of the company's revenue comes from real estate development of new structures or construction projects.
IMPACT ON STAKEHOLDER(S)	Decisions made in the real estate development and design process—such as appliance selection, building energy efficiency, construction materials, and energy source availability—impact the long-term energy and emissions performance of the structure.
IMPLEMENTED MGT PRACTICES	Haven Ventures has the following practices in place to minimize the energy and emissions associated with its real estate projects: Appliance Energy Usage: Uses system vision, energy star, and water sense appliances that reduce the amount of energy its developments consume Building Systems & Energy Performance (insulation): Utilizes SIPs or other highly insulated building systems to ensure that the HERS rating is as low as possible. The company contracts a third party company to provide energy models on all of developments, and they are typically at least double as efficient as the industry standard. Construction Material Waste: Controls the design process so that spaces are designed to eliminate the amount of waste produced, meaning the product fits the space perfectly and does not need to cut off 'remaining' amounts (i.e. a wall can be drywalled with 4x8 sheets without any cutting) Emissions from Material/Product/Subcontractor Transportation: Sources through local suppliers and subcontractors to limit the amount of transportation necessary.
