



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	SO - IL OFFICE LTD laid off 4 employees in 2020. Many of company's projects were put on hold, including all fee payment. Company was forced to downsize significantly. Employees were given private meetings with upper management in which several options were made available to them including reduced hours, reduced salary and unemployment (if eligible). Many chose to reduce their work hours for several months with the understanding that it would be best to make other arrangements prior to being fully laid off by August 2020.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	4 employees were laid off, representing 20% of the company's employees at that time.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment and international employees returning to their home countries.
IMPLEMENTED MGT PRACTICES	Laid off employees were offered to be paid unemployment for a period of time. Company did not explicitly offer them to come back after the pandemic.
