SUMMARY OF ISSUE	As a brewery, Brick Lane Brewing Company operates in an industry that is water intensive.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 99% of Brick Lane Brewing Company's revenue was earned from the sale of alcohol. The company uses 4.1L of water for 1L of beer.
IMPACT ON STAKEHOLDERS	As a water intensive industry, brewing poses risks such as water stress or depletion of local water sources if water use is not appropriately managed. Brick Lane Brewing Company's water supply comes from the Melbourne municipal water supply, supplied by Melbourne Water. Melbourne's water supply is from surface water catchments – those used in Brick Lane Brewing Company's manufacturing operations are located in the west of the city, primarily the Cardinia Reservoir. As a percentage, Brick Lane Brewing Company's water usage has no material impact on water storage levels in this reservoir or the wider network, however Brick Lane Brewing Company does measure and set KPIs around water intensity and implement improvement project regularly. Melbourne's water storage levels have been steadily decreasing since the early 2000s, due to increasing population, longer dry periods and pressure from fire. Due to higher rainfall associated with the current La Nina cycle, storage volumes are >80% capacity, and water security has been further improved by installation of a large scale desalination plant. Despite this, the longer term trend points to water-stress in the medium term, and to address this Brick Lane Brewing Company has set KPIs around water intensity, and has run several focussed improvement projects reducing water use.

IMPLEMENTED MGT PRACTICES	The company has numerous water saving initiatives in the brewery, some of the more notable include:
	 a) The installation of a state-of-the-art plant to reduce water intensity. For example, the 100hl brewhouse is specified for 40 brews between cleans, greatly reducing the water and wastewater requirement for cleaning in this area. Brick Lane Brewing Company has installed three automated CIP sets to automate cleaning, allowing optimisation and standardisation to reduce water use in cleaning. They have also two centralised mixed water tanks for re-capturing and reusing rinsewaters for pre-rinsing during CIP processes. The company has installed low volume, high pressure jet cleaning machines in all large capacity CCTs in the brewery to reduce cleaning liquid volumes; and have implemented a focused improvement project in our pasteuriser to eliminate the requirement for potable water used to cooling, saving 9 million litres in the past 12 months. b) The company measures and tracks their water intensity and benchmark against others in our industry. From FY23, Brick Lane Brewing Company will publish this data publicly. c) Brick Lane Brewing Company uses recycled water in garden watering. d) Brick Lane Brewing Company have set water reduction target of <4:1 in FY23. Brick Lane Brewing have since exceeded this target having reached a water to finished product ratio of 3.7:1 in FY22.
	e) The company benchmarks on water efficiency against similar breweries on a national and international basis, using benchmarking data from the US Brewers Association and the Australian Independent Brewers Association. The company also records wastewater quality and volume data.

SUMMARY OF ISSUE	Brick Lane Brewing Company is a brewery that earns a material amount of revenue from the sale of alcohol.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 99% of Brick Lane Brewing Company's revenue was earned from the sale of alcohol.
IMPACT ON STAKEHOLDERS	Alcohol may have a negative impact on the health and well-being of individuals and their communities.
IMPLEMENTED MGT PRACTICES	Brick Lane Brewing Company complies with all regulations and laws. The company holds a Producer's License (licence number 32808535) administered by the Victorian (""VIC"") Government, which allows the company to sell alcohol on and off premise at its own venue and at events. The company also holds a Producer/Wholesale Licence (license number 226992) administered by the Queensland (""QLD"") Government, which allows the company to sell alcohol on and off premise at its own venue and at events. It is a condition of employment that ALL serving staff hold a current Responsible Service of Alcohol (""RSA"") certificate valid in Victoria. Brick Lane Brewing also has a strict Drug and Alcohol Policy which is adhered to by all team members. Brick Lane Brewing voluntarily displays health warnings and logos on their cans. All of Brick Lane Brewing's public communications incorporate people who look 25 years old or older and the company encourages the responsible consumption of alcohol through their messaging. For example; a. All of Brick Lane Brewing's public images have a responsible amount of drinks split per person. b. Brick Lane Brewing does not post about beer on social media prior to 12 noon. c. Brick Lane Brewing has a low alcoholic beer option - 1.1% ABV (or 0.3 of a standard drink).
