Summary of Issue	ProServeIT Corporation is a company that provides managed IT services, alarm guardian product, hardware products, microsoft products/licenses, technology roadmap, and other IT centred products and services to clients in controversial industries such as For-profit higher education, Mining, Pharmaceuticals, and Fossil Fuels (coal, oil sands) .
