Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Summary of Issue	Beemine Lab, based in Spain, produces and sells cosmetics infused with legal CBD (cannabidiol).
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The total revenue (100%) of Beemine Lab for the last fiscal year (2022), came from CBD related products.
Impact on Stakeholders	Cannabis-related products are subject to controversy both because of their current and historic legal status around the world, as well as concerns about the potential harm that the products may cause. Current regulations governing the legality of cannabis-derived products are complex and vary widely by local jurisdiction.
Implemented Management Practices	The Beemine Lab submitted audits to the AEMPS for better understanding of the viability and safety of the products. The products go through rigorous examinations regarding stability, sensitivity and labeling information. The Beemine Lab complies with current regulations for Spain and the European Union for CBD and cosmetics. All of the products are notified to: 1. European Cosmetics Portal, 2. Spanish Agency for Medicines and Health Products (AEMPS), and 3. Official College of Pharmacists.
