Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Recalls

Topic	Recalls due to quality control issues
Summary of Issue	Lü Aire de jeux has had 1 recall in the last five years due to quality control issues. The issue happened with the Mobil product. Lü Aire de jeux was notified of an incident because of misuse by a user. The user lifted the lifting tower to the maximum height (exceeding the installation specs) and forced the mechanism, which ruptured the cable and the product dropped. After the incident, Lü Aire de jeux voluntarily recalled all products that had reached consumers to improve it and avoid similar incidents.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Lü Aire de jeux requested a recall of 251 products (responsible for 18% of the existing and deployed products), which represented 23% of the total revenue.
Impact on Stakeholders	There was one customer affected by the incident, with no injuries caused. With the recall, the risk was eliminated and there were no other incidents.
Resolution	An investigation was developed with the tower manufacturer, and the engineering team designed a safer system to replace the handle.
Implemented Management Practices	A process with Investissement Québec CRIQ was initiated to investigate all certifications that could be applicable to all products, in all the markets Lü Aire de jeux sells to, to ensure the safety of all existing and future products. In addition, Lü Aire de jeux designed a system to replace the handle of the tower, with a new handle including a tork limiter. This update in the product would avoid the possibility for a user to apply excessive strength to the handle which can result in a rupture of the cable and potential harm.
