



DISCLOSURE MATERIALS

TOPIC	Significant layoffs due to reduction in client demand
SUMMARY OF ISSUE	Due to reduction in client demand, IE Design Consultancy Ltd had to lay off 4 employees between January and July 2020.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	4 employees were laid off, representing 22.2% of the company's employees at that time.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	IE Design Consultancy Ltd provided statutory redundancy payment. The UK Government's Furlough scheme was used to extend the employment of 2 out of the 4 employees. One was offered redeployment but refused, one subsequently started their own business and IE Design Consultancy Ltd is the company's biggest client. All 4 went on to find alternative employment / self employment within 2 months. IE has always monitored and reported upon its Order Book (the value of confirmed work awaiting delivery) because of its importance as a financial cushion that protects staff from potential future layoffs. IE's Order Book has increased in value by 119% since July 2020 and as at September 2022 stands at just over £1.1m.
MANAGEMENT COMMENTS	IE retains HR Dept (external HR consultancy) who oversee all HR processes including staff handbook, contracts, redundancy processes etc.
RELATED INCIDENTS (YES/ NO)	All 4 incidents occurred in the calendar year 2020, but they were split across two financial years (year to 30 June 2020 and year to 30 June 2021)
