Disclosure Questionnaire Category: Operations located in Conflict Zones

Topic	Making Cents International operates in Conflict Zones
Summary of Issue	Making Cents International Operates in Conflict Zones: Making Cents International is a development consulting firm that creates economic opportunities for youth and adults in developing countries. Part of the firm's operations include Ukraine, the West Bank and Gaza, and South Sudan, providing services such as assessments, capacity building for non-governmental organizations engaged in humanitarian or development work, and program evaluations. Making Cents International received funding indirectly from USAID through IREX to support youth-led organizations and entrepreneurs with capacity-building initiatives. Ukraine is a conflict-affected zone due to Russia's ongoing invasion and occupation, with continued fighting and attacks across the country. The West Bank and Gaza face persistent Israeli-Palestinian violence, military operations, and frequent clashes that impact civilians and infrastructure. South Sudan experiences ongoing political violence and clashes between government forces and opposition groups, despite peace agreements.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In fiscal year 2024, 7.1% of the company's revenue was derived from operations and projects in Ukraine, and 0% from the West Bank and Gaza, and South Sudan.
Impact on Stakeholder(s)	Business activities located in conflict zones are considered high-risk as they are more likely to cause or contribute to the conflict and/or sociopolitical instability. Countries classified as conflict zones are more likely to have a weak rule-of-law or a corrupt judicial system, which could undermine the effectiveness of operational grievance mechanisms for these businesses and their suppliers. In addition, the safety of the company's workers and other potential human rights violations are at risk.
Implemented Management Practices	Making Cents International has a suite of insurance and security policies designed to protect staff and uphold a strict "do no harm" approach. The international insurance policy covering



Making Cents International also has a crisis management plan that applies to all traveling staff. Specifically for Ukraine, however, travelers follow IREX's Ukraine Security Management Plan, which is designed to ensure a safe operating environment and establish clear security and safety practices tailored to the country's unique conditions.
