[Industries at Risk of Human Rights Violations] GreenCollar's Ghana Plastics Project operates in Ghana where traditionally, many families rely on the income from additional revenue generated by children who collect and sell plastic waste. As such, this project may have a high risk of human rights infringement. To mitigate the risk of child labour, GreenCollar has undertaken number of activities to reduce the risk of human rights infringements with respect to child labour. GreenCollar maintains a Risk Register incorporating an incident assessment, and response team for the review, monitoring and control of child labour issues. Further, to proactively minimise child labour risks, has drafted Child Labour Policy and provides training to appropriate staff. Independent child labour experts are hired to interrogate the value chain, identify any child labour risks and report them to GreenCollar. The Child Labour Monitoring and Remediation System (CLMRS) provides an ongoing mechanism to identify, monitor, remediate and prevent cases of child labour in project activities. In partnership with Environment 360, GreenCollar has also developed a best practice waste picker registration system for keeping and validating documentation to verify ages of employees and plastic waste collectors, after they are hired or recruited. [Litigation and Arbitration] The dispute was regarding the alleged improper use and exploitation of intellectual property associated with a carbon accounting methodology. The matter is brought via derivative action whereby the plaintiff is a company in respect of which GreenCollar has a 50% stake and the founders of GreenCollar had previously been directors. The defendants are the founders of GreenCollar and companies in the GreenCollar Group. The Plaintiff seeks an account of profits. GreenCollar and its founders are vigorously defending the claim, which is currently active in the Federal Court of Australia. This dispute has minimal to no impact on GreenCollar's stakeholders. [Labor Issues] A casual Field Technician was terminated due to performance grounds. A general protections claim was lodged by the terminated casual employee to the Fair Work Commission. The employee alleged that the Company had ended their employment due to a protected attribute specifically related to their disability. GreenCollar took part in a conciliation and denied the claims that it terminated the employees employment because the employee had a disability and that it treated the employee differently because of it. The Company presented its findings which consisted of multiple performance/conduct concerns. The Company did not agree to make any payments and there was no further action taken by either party. GreenCollar implemented training programs on appropriate workplace behaviour which includes but is not limited to discrimination, bullying, sexual harassment and victimisation
