



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ISSUE DATE	March 2020
TOPIC	Indosole defaulted on a loan from crowd funding platform Kiva.org in 2019
SUMMARY OF ISSUE	In mid 2019, Indosole defaulted on a loan of US\$100,000 raised via the Kiva platform which enables micro loans from funders to support entrepreneurs and small companies that are generally not able to receive loans from conventional loan institutions. In early 2020, B Lab received a complaint against Indosole from a funder of the platform as the company had been defaulting on their monthly repayments since August 2019.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The loan accounted for 11.29% of revenues in 2020. The company paid back US\$27,775 of the US\$100,000 loan before defaulting on the loan due to financial difficulties. This is the fourth and largest loan that Indosole has received via the Kiva platform, all other loans were repaid in full.
IMPACT ON STAKEHOLDERS	The loan accounted for 11.29% of revenues in 2020. The company paid back US\$27,775 of the US\$100,000 loan before defaulting on the loan due to financial difficulties. This is the fourth and largest loan that Indosole has received via the Kiva platform, all other loans were repaid in full.
IMPLEMENTED MGT PRACTICES	Writing a letter - working to pay off any debts and everything is up to date.
RESOLUTION	By way of a third party, Indosole came to an agreement with Kiva.org in 2021 to repay 10.71% of the remaining US\$72,277.76 which amounts to US\$7,740.95. The remaining settlement was to be paid over a five month period.
