

## DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

<b>TOPIC</b>	Significant layoffs due to the impacts of COVID-19
<b>SUMMARY OF ISSUE</b>	During the COVID-19 pandemic, 4 employees responsible for consumer marketing activities were let go due to the forced lockdowns and the closure of the company's retail locations.
<b>SIZE/SCOPE OF ISSUE</b> (e.g. \$ financial implication, # of individuals affected)	4 employees were let go, representing 24% of the company's employees at that time.
<b>IMPACT ON STAKEHOLDERS</b>	Primary impact was loss of employment for affected employees.
<b>IMPLEMENTED MGT PRACTICES</b>	<p>"The company provided two months of severance compensation to those laid off, as well as employment support and a strong reference letter. They also reached out to our network of investors and accelerators to help provide career opportunities immediately. Three of the four affected employees end up taking jobs through the company's recommendations within a month of the layoff.</p> <p>They also worked with their lawyers to create a comprehensive unemployment support package, including healthcare, during the time of transition."</p>
