ECOstyle Holding B.V. is involved in the production or sale of animal products and services, meaning that they are more likely to have significant impacts on the environment and animal welfare. Certified B Corps are required to make transparent their involvement in such industries.

# Disclosure Questionnaire Statement

## Disclosure Questionnaire Category: Biodiversity Impacts

<b>Topic</b>	ECOstyle Holding B.V. manufactures fertilizers and pesticides.
<b>Summary of Issue</b>	Company manufactures 100% organic fertilisers and potting soil, these include pesticides (active ingredients allowed in organic farming). None of the company's products include herbicides which are not allowed in organic farming. The company complies with Regulation EU 2018/848 on organic farming.
<b>Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)</b>	Almost all company's products are bio-based except Ultima MH and Siltac. The revenue of these products represents 2.41% of the total revenue.
<b>Impact on Stakeholders</b>	Agriculture poses a risk to local ecosystems of flora and fauna as well as the potential degradation of cultivated land.
<b>Implemented Management Practices</b>	<ul style="list-style-type: none"> <li>- The vast majority (80%) of the company's customers are private users who use the products in their own households. These are not professional users. The professional users (20%) are active in the green sector or agriculture and horticulture. They used the company's green products as an alternative to synthetic agents on their non-GMO crops,</li> <li>- The company's policy is that no Personal Protection Products (PPPs) should be required when using its products for non-professional users. Whether PPPs are mandatory is assessed under EU legislation such as CLP/REACH by Echa, or national authorization authorities such as the Ctgb (<a href="https://toelatingen.ctgb.nl/nl/authorisations">https://toelatingen.ctgb.nl/nl/authorisations</a>). For professional products PPPs are mandatory by law, independent of their CLP classification (Hazards). Therefore, the company's policy is to not sell professional products that are not organically degradable or have certain Hazards for users. All of the company's products are based on the natural actives or microbials,</li> <li>- Reuse of packaging of plant protection products is not allowed in the EU. In the Netherlands, professional users must have the packaging collected by an organisation called Storl (<a href="https://www.storl.nl/">https://www.storl.nl/</a>), which ensures adequate disposal. Non-professional users must comply with national and municipal regulations on packaging collection. ECOstyle Holding's policy on packaging is to use the most sustainable alternative, such as recycled plastic or paper.</li> </ul>
<b>Report</b>	- There is a database that shows EUROstyle as a registered
