Disclosure Questionnaire Category: Biodiversity and/or Monoculture

Topic	Litigation & Arbitration, related to breach of contract with Suppliers
Summary of Issue	In the past five years, two litigation cases were brought up against Maison Boinaud by 2 suppliers for breach of contract terms. The suppliers contested the abrupt termination of the contract without prior notice as stipulated in the terms of their supplier contracts. Case 1 was settled and closed with the company making a payment to the supplier. Case 2 is still pending with possible likelihood to lose by the company.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The financial value for both cases represented approximately € 101 037.99, <1% of the company total revenue. Case 1 represented €50.000 and Case 2, € 51 037.99.
Impact on Stakeholders	The stakeholders affected were the suppliers and MAISON BOINAUD
Resolution	1 case has been settled and closed and corresponding payment has been made. 1 case is still pending.
Management Practices	The company invested in re-training its employees on contract process management. In addition to that, the company revised their supplier contract document to be more elaborate.
