Topic	Clients in Controversial Industries
Summary of Issue	Cosucra Groupe Warcoing is a raw material supplier who serves clients in the Breastmilk Substitute industry; providing fiber ingredients that enhance the digestibility of those products. The company's product can also be sold to non-controversial industries as a dietary fiber to enhance stool frequency, consistency and reduced constipation.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Clients in this industry have represented 5% of the company's revenue on a yearly basis over the last 5 years.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company does not currently have a policy for working with clients in controversial industries nor carries out due diligence of clients they work with to ensure that the product provided is not used for harming people and the environment.
Management Comments	FIBRULINE™ chicory root fiber, inulin and polyfructose, as well as FIBRULOSE™ chicory root fiber, oligofructose belong to the inulin-type fructans, also known as FOS. They are part of the solution to mimic mother milk oligosaccharides in baby food formulae for those who did not have access to breastmilk. Combined with GOS (galacto-oligosaccharides), HMOS (human milk oligosaccharides obtained by precision fermentation) or probiotics, they are well recognized by the industry leaders as well as the national regulatory authorities based on peer reviewed science. The company's product, can also be sold to non-controversial industries as a dietary fiber to enhance stool frequency, consistency and reduced constipation.
