

DISCLOSURE MATERIALS

SUMMARY OF ISSUE	KOA+ROY sells a Massage Cube, which contains 200 milligrams of Hemp extract, also known as CBD, which is a non-psychoactive compound derived from organically grown hemp. The company sources the hemp oil from a local company from domestic grown non-GMO Hemp.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Currently, KOA+Roy has the Massage Cube as the company's sole product, so 100% of the company's revenue comes from the sale of the Massage Cube.
IMPACT ON STAKEHOLDER(S)	Current regulations governing the legality of cannabis-derived products are complex in the United States due to different layers of federal, state, and local laws. Thus, the legal landscape around such products, particularly CBD, is somewhat ambiguous at this time. There are many companies that do sell legally CBD products, which are designed to be non-psychoactive. While the risk of criminal prosecution may be low or negligible, B Lab encourages consumers, retailers, and manufacturers to conduct their own research based on individual circumstances to determine the legality of certain cannabis-derived products in one's jurisdiction.
IMPLEMENTED MGT PRACTICES	The Hemp extract the company uses is an isolate, meaning there is no THC, only CBD in the Massage Cube. It is extracted using supercritical CO2. For every batch ordered, the company obtains a Certificate of Analysis that is Triple Lab Tested confirming that the content is 0% wt. THC and over 99.67% CBD.
