TOPIC	Animal testing required by law
SUMMARY OF ISSUE	As required by law, 100% of Ferrer's drug products are experimented with animals. The regulations of the different regulatory pharmaceutical agencies explicitly and in detail require the carrying out of studies in experimental animals. Additionally, some chemical substances manufactured by Ferrer also need to be tested on animals according to the law when no alternative or no bibliographic data is available.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Approximately 100% of Ferrer's drug products revenue and 50% of its chemical products revenue are derived from products tested with animals.
IMPACT ON STAKEHOLDERS	Animal testing is a material issue in the pharmaceutical industry due to the potential for adverse health reactions caused to animals involved in the process.
IMPLEMENTED MGT PRACTICES	"In order to carry out experiments that require animal testing, Ferrer partners with public universities, public hospital research institutes, and contract research companies (CRO). All the centers that Ferrer hires comply with the European directives (Directive 2010/63 / EU as amended by Regulation (EU) 2019/1010) as well as the regulations of the Member States and the regions on the subject, including mechanisms for approving protocols and Ethical Committees for Animal Welfare.
	Ferrer uses the 3R criteria (Replacement, Refinement, Reduction), which seeks to reduce the use of experimental animals by applying replacement criteria for in vitro experiments or for inferior species (e.g. using invertebrates instead of vertebrates), optimization of protocols to increase animal welfare, and reduction of number of animals used.
	For example, for Drug Drug Interactions (DDI) Studies, the company routinely approaches this topic using in vitro metabolic studies with human enzymes and routinely avoid specific in vivo pharmacokinetics studies using live animals treated with a pair of drugs. For genotoxicity studies, Ferrer routinely avoids in vivo testing when possible — for example, if a compound is determined to be genotoxic in any of the in vitro tests the company relies on this result and skips the in vivo test. In addition, in cases where a modification of the route of administration does not provide sufficient target tissue exposure, Ferrer negotiates with the Authorities to base the evaluation only on in vitro testing."

TOPIC Ferrer manufactures and sells pharmaceutical products based on chemcial inputs As a company that manufactures and sells pharmaceutical products, Ferrer operates in an industry where chemical inputs are a material issue. SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected) 100% of Ferrer's products contain chemical inputs
The primary potential impacts of chemical use in pharmaceutical products are potential negative effects to the environment and potential negative health impacts to workers exposed to chemical ingredients. In the last five years, Ferrer has not experienced any incidents and/or fines related to environmental or worker impacts of its chemical use.
"Ferrer has a product safety unit that is responsible for detecting, evaluating, and improving the management of hazards for all chemical products during all aspects of the lifecyle (transportation manufacturing, and disposal). The level of hazard is analysed in terms of human exposure, physical danger (e.g. risk of explosion), and negative environmental effects through an integrated management system across all factories. Identified risks are mitigated by improving protocols, adapting facilities, and designing protective gear for factory workers, among other practices. All of Ferrer's products have been tested and approved as safe and effective by the relevant health authorities and the company has a dedicated pharmacovigilance unit that is responsible for detecting, evaluating, and improving adverse reaction to drugs. SUMMARY OF ISSUE	In the last 5 years, there have been 7 instances where Ferrer and/or its manufacturing partners have issued a recall of a particular product due to quality issues. The types of quality issues that have prompted recalls include deviations from manufacturing standards, product testing results that fall outside quality specifications, allergy risks, and labelling issues.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The value of recalled products in the last 5 years amounts to less than 0.07% of the company's annual revenue
IMPACT ON STAKEHOLDERS	Some recalls may have posed a health risk to consumers, specifically those prompted by potential allergy risks or the detection of potentially harmful substances during product testing. Importantly, there have been no reports of adverse drug reactions nor safety related complaints from consumers related to these recall events.
RESOLUTION	In all instances, Ferrer recalled all affected units from the relevant channels and its own stock.
IMPLEMENTED MGT PRACTICES	"In instances where a supplier or subcontractor was responsible for a product quality issue, Ferrer took steps to either downgrade its internal supplier qualification status and implement corrective and preventative actions, perform additional risk evaluations as outlined in ICH Q9 and ICH M7 guidelines, or cease working with the manufacturer. For the recalls related to labelling, the company formed an internal working group made up of Marketing, Regulatory, Technical Director, Compliance, R+D and Medical departments, which worked to review claims compliance according to the current European guidelines on that issue."
