Issue Date	2021 - 2024
Topic	Labor issues and contract disputes with suppliers
Summary of Issue	The supplier alleged that the company failed to pay for services and products. In addition, a supplier is alleged to have defaulted regarding its employees regarding the following entitlements: (a) payment of severance pay and (b) application of corresponding fines. For these last cases, Faro's responsibility is subsidiary, meaning Faro is only held liable if the contractor/supplier fails to comply with any potential judgment.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The total financial value associated with these cases is approximately R\$ 2,800,000.00.
Impact on Stakeholders	Contract disputes and labor issues impact business relationships, which can generate financial, mental, wellbeing and reputational impacts on the affected parties.
Resolution	The company has 34 cases pending resolution and 8 cases ruled against them.
Management Practices	The company has improved control of third-party obligations with its employees and contractors. The company has implemented a document control system for suppliers with field activities. Through this system, they are able to monitor all tax, labor, and social security obligations of the suppliers, who are required to submit all necessary documentation before any invoicing and/or payment.
