Topic	The company operates in a sensitive ecosystem. Operate within the Machalilla National Park, a natural protected area.
Summary of Issue	The company offers luxury yacht expeditions in protected areas designated by the Ecuadorian government's "Sistema Nacional de Áreas Protegidas. The company operates in the Machalilla National Park, which boasts diverse primary forests and marine ecosystems. This area is home to a variety of plant formations, forests, mangroves, intermediate vegetation, reefs, corals, and more.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	80% of the company's facilities are based in a sensitive ecosystem. In the previous fiscal year 100% of revenues was earned from operating in the sensitive ecosystem
Impact on Stakeholders	Kontiki Expeditions S.L activities may pose a risk to the natural ecosystem, including non-hazardous and hazardous waste contamination that could harm and contaminate the area's flora and fauna. This could include spills of hydrocarbons.
Implemented Management Practices	In order to mitigate potential risks, the company has implemented a security management system. This system includes policy and procedures for managing hazardous and non-hazardous materials, as well as instructions for responding to hydrocarbon spills.
