Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Company sells cannabis-derived products
Summary of Issue	The Human Beauty Movement sells creams and oils that are formulated with industrial Hemp. The company only sells products for topical use (no ingestible). Their supplier is in compliance with all regulations.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Around 54.7% of the company's revenue is derived from products with industrial hemp.
Impact on Stakeholders	Cannabis-related products are subject to controversy both because of their current and historic legal status around the world, as well as concerns about the potential harm that the products may cause. Current regulations governing the legality of cannabis-derived products are complex and vary widely by local jurisdiction.
Implemented Management Practices	• Humanist Beauty abides by all federal and California state regulations in the sourcing and sale of topical products formulated with CBD, • The company's hemp supplier has signed a Supplier Code of Conduct, in which they are required to comply with all relevant and applicable laws and regulations of the country, • The company abides by the California Bureau of Cannabis Control to test our raw CBD extract for Cannabinoids Potency, Residual Solvents and Processing Chemicals, Residual Pesticides, Microbial Impurities Testing (Escherichia coli and Salmonella spp.), Foreign Material, Terpenoids, Mycotoxins, and Heavy Metals, • Humanist Beauty monitors state laws to ensure it is not shipping Herban Wisdom Facial Oil and Eye Cream to states where CBD is not legal, • The company has a public webpage outlining its "Terms of Use" where it states: <i>"All material and information presented by Humanist Beauty is intended to be used for personal, educational or informational purposes only. The statements made about products have not been evaluated by the U.S. Food and Drug Administration or any other government agency and the results reported, if any, may not necessarily</i>
