



DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Perkier Food Ltd is a company based in the UK and sells snack bars. Some of them are made with chocolate. As a company that sources cocoa, Perkier Foods Ltd is part in an industry in which human rights issues such as forced labor, child labor, and human trafficking are prevalent globally in the cocoa supply chain.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Among the company's snack bars, 59% are chocolate-based. Approximately 0.6% of Perkier Foods' supplier expenses are destined to cocoa suppliers.
IMPACT ON STAKEHOLDERS	The global cocoa industry has a history of forced and child labor, which subjects workers to poor working conditions, low wages, and puts children at risk for human trafficking.
IMPLEMENTED MGT PRACTICES	• Perkier Food's Supplier Code of Conduct covers quality, safety, compliance, environmental and supply chain traceability criteria, • As part of the company's raw material approval process, suppliers must complete the company's Ethical Trading questionnaires. By signing the SAQ the supplier declares that they are compliant with all relevant EU and Great Britain's retained regulations, • The company does not source from any suppliers whose ethical policy does not align with the company's or who decline to complete its Ethical Questionnaire. • The company's co-manufacturer is a member of SEDEX and B Corp, • In terms of traceability, the company's cocoa supplier has a traceability system according to GFSI standards (Global Food Safety Initiative), • The company's cocoa suppliers have their own Ethical and Human rights due diligence policy in place
