Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Clients in Controversial Industries
Summary of Issue	Better Future is an impact consultancy firm that facilitates businesses by delivering tailored leadership and strategy programs and workshops to clients, contributing to a better future and creating a more positive impact on the world. The company had clients in the Fossil-Fuel (non coal/oil sands), Water Utilities and Whole Life Insurance Products industries, which are deemed controversial by B Lab. The services provided to the clients can be sold to other clients in different industries, including other both non-controversial and controversial industries, although it is tailored from client/industry to client/industry.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the fiscal year end of 2023, the company had earned 14% of total revenue from clients in the fossil-fuel industry and 2% from clients in the whole-life insurance industry. The company has yet to earn revenue from the water utilities industry as the project is ongoing.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Better Future currently does not currently have a formal position on working with particular sensitive industries or a policy to move away from them. In terms of client screening, the company assesses the level of sustainability of its potential clients based on the information

	provided on their websites. Better Future helps organizations through leadership and strategy programs to contribute to a better future (as their company name already indicates) and to create a more positive impact on the world, even when collaborating with clients in controversial industries.
