



DISCLOSURE MATERIALS

SUMMARY OF ISSUE	Bruichladdich Distillery Co. Ltd is a distillery that earns a material amount of revenue from the sale of alcohol
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 100% revenue was earned from the sale of alcohol
IMPACT ON STAKEHOLDER(S)	Alcohol may have a negative impact on the health and well-being of individuals and their communities
IMPLEMENTED MGT PRACTICES	The company complies with all of the regulations and laws related to the sale of alcohol in the UK where it operates. Bottles of alcohol produced are labelled with the UK Chief Medical Officer recommendation, which is not to consume more than 14 units per week of alcohol. Through their product labels, the company requests consumers to drink responsibly and provides a link to DRINKAWARE.co.uk for further health information. Drinkaware is an independent charity working to help people make better choices about drinking and reduce alcohol misuse and harm in the UK.

TOPIC	Water Intensive Industries
SUMMARY OF ISSUE	As a distillery, Bruichladdich Distillery Co. Ltd operates in an industry that is water intensive. Aspects of the industry that make it water intensive include the distilling process, reduction, and cooling.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 100% revenue was earned from the sale of alcohol. The company utilises ~200 litres of water per litre of pure alcohol, for cooling, process and reduction within the distillery.
IMPACT ON STAKEHOLDER(S)	As a water intensive industry, alcohol production poses risks such as water stress or depletion of local water sources if water use is not appropriately managed. In the case of Bruichladdich Distillery Co. Ltd, nearly all of its water supply is sourced from a private reservoir that is fed by rainwater.
IMPLEMENTED MGT PRACTICES	Bruichladdich Distillery Co. Ltd monitors its annual water consumption for each step of the production process, and as a member of the Scottish Whisky Association is committed to improving the water efficiency of its distilling processes by 10% by 2020. 87% of the company's total water used is returned to the water table at the same quality. The company also uses hot waste water from its production to heat its facilities.
