## Disclosure Materials

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

# Disclosure Questionnaire Statement

## Disclosure Questionnaire Category: Operations located in Conflict Zones

<b>Topic</b>	Company has suppliers located in Conflict Zones
<b>Summary of Issue</b>	<p>Aasted ApS, based in Denmark, is a solutions provider for the chocolate, bakery, and confectionery industries. The company has a Tier 1 supplier located in Kyiv, Ukraine.</p> <p>According to the Global Conflict Tracker, <a href="#">Ukraine</a> is currently a conflict zone due to the ongoing war with Russia. Before the conflict, this supplier was the company's primary source for steel frames used in equipment. Despite the war, Aasted ApS has continued to work with this supplier as much as possible. However, it has also become necessary to source from supplementary suppliers outside of Ukraine.</p>
<b>Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)</b>	During the fiscal year 2023, approximately 10% of the company's supplier spending was allocated in conflict zones.
<b>Impact on Stakeholders</b>	<p>Business activities located in conflict zones are considered high-risk as they are more likely to cause or contribute to the conflict and/or sociopolitical instability.</p> <p>Countries classified as conflict zones are more likely to have a weak rule-of-law or a corrupt judicial system, which could undermine the effectiveness of operational grievance mechanisms for these businesses and their suppliers. In addition, the safety of the company's workers and other potential human rights violations are at risk.</p>
<b>Implemented Management Practices</b>	<p>To engage with new suppliers in both conflict zones and non-conflict zones, the company employs a country risk assessment tool that evaluates ESG (Environmental, Social, and Governance) risks and sanctions. This assessment covers various factors, including:</p> <ul style="list-style-type: none"> <li>• Human Rights: evaluated using the Fragile States Index</li> <li>• Labor Rights: assessed through the Global Slavery Index and the Global Rights Index</li> <li>• Corruption: measured by the Corruption Perception Index</li> </ul>

	<ul style="list-style-type: none"><li>• Environmental Impact: analyzed using the Environmental Performance Index, Ecosystem Vitality Index, and Carbon Intensity measures</li><li>• Political and Economic Risk: assessed through the Atradius Country Risk Map</li><li>• General Country Risk: reviewed via RiskMap</li></ul> <p>This risk assessment relies on indices from independent organizations such as Transparency International, The Fund for Peace, and Yale University.</p> <p>The company has established a code of conduct for suppliers and requires all suppliers to complete an impact questionnaire that reviews their sustainability performance every two years. In 2024, the company began auditing its suppliers on sustainability topics, focusing on human and labour rights, as well as safety conditions.</p>
