Topic	Clients in Controversial Industries
Summary of Issue	Schuttelaar & Partners is a communication and public affairs advisory company that has had clients in the GMO industry. The nature of the company's services with clients in this industry has been related to public affairs strategies. Their services are available to both controversial and non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In FY22-23, the revenue from clients in the GMO industry represented 1% of the company's annual revenue.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Schuttelaar & Partners has a responsible lobbying policy in alignment with the Responsible Lobbying Framework. The Public Affairs team meets at least once a month to share good practices, put knowledge in common, and offer training. The PA team leader, together with the respective partners and managers, are available to guide and offer help to any of the consultants whenever a doubt arises regarding the applicability of their internal policies. Different additional internal sessions during the year are offered on the way of working for the people involved in PA activities.
	PA activities as based on trust and honesty and never on donations or similar. S&P does not give any political donations or gifts apart from the only donation they make at the end of the year for a good purpose like the Foodbank. For certain events, merchandise can be produced (leaflets or bags) but the individual value of those is miniscule. The public affairs strategies developed for their clients never included any gifts or



donations.
