TOPIC	Litigation related to breach of California Proposition 65, a California law to protect drinking water sources from toxic substances that cause cancer and birth defects and to reduce or eliminate exposures to those chemicals, by requiring businesses to warn Californians about certain chemicals in the environment and/or consumer goods.
SUMMARY OF ISSUE	2019, April - a claim was received from the consumer agency As You Sow, related to breach of California Proposition 65. The case was settled in March 2020. 2021, September - four claims were received from the consumer agency Environmental Research Centre, related to the same breach of California Proposition 65 for Huel Power and Huel Ready-To-Drink products. The cases were settled March 2022.
	Both cases related to the Huel website not displaying the California Proposition 65 warning.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	All five cases reached a settlement totalling <1% of the company's total revenue each.
IMPACT ON STAKEHOLDERS	Both cases involved two consumer agencies. However, the nature of the issue posed a risk that people in different geolocations could not see the California Proposition 65 warning.
RESOLUTION	All five cases have been settled and closed.
MANAGEMENT PRACTICES	The company undertook extensive legal advice to understand the parameters for selling products compliantly in the US and implemented product labelling to ensure compliance. The company has resolved the issue.
MANAGEMENT COMMENTS	With Huel, our number one priority is the health and well-being of our customers. Our quality standards include us regularly testing our products for the presence of heavy metals. Huel products are manufactured in FDA-approved facilities that follow federally regulated current Good Manufacturing Practices (cGMP). No changes to our formulas are mandated by law, and we stand by the quality and safety of all Huel products. The trace presence of heavy metals present in the ingredients of Huel products are highly likely to be the result of natural phenomena in regions where our ingredients are grown, such as glacial action.
