## Boisset's Brew Pub, Chiarello's Platform 8 Approved by Council

spent hours Tuesday dis-cussing the details of plans presented for the Yountville Brewing Company by vintner and businessman lean-Charles Boisset and chef and restauratrur Michael Chiarello for Platform 8, a high tech hamburger joint, where diners will order their meals via iPads. and ice cream will be made to order with liquid nitrogren in a "lab," But fundamentally none of the five members were opposed to the two concepts presented, and both won their approval.

The new brew pub will be

located in the Whistlestop Center in the space currently occupied by the Overland Sheepskin retail store.

Boisset's planning consul-tant Donna Oldford told the Council, "We have solved the parking problem" and noted that all drinking and dining has been moved inside, reducing exterior noise.

She predicted the business will be an attractive addition to Yountville's business community, adding diversity and serving the needs of both locals and visitors.

Kevin Bloch, attorney for Lori Altamura Jones, owner of The Railway Inn, agreed progness had been made on the brew pub plan but said the site is still a very challenging one and disruptive to his client's existing business.

He suggested the Council write a 550-gallon beer production limit into the use permit, eliminate four tandem parking spaces which he said will be eyesores for inn guests and eliminate food take-out

service from the pub. 8loch further said Yountville's ordinances and codes prohibit tandem parking in business zones.

Town Manager Rogers, noting that the pub plans call for spring water to be trucked into the site for the brewing process, said it will be Platform 8 site was fenced off necessary to quantify the amount of water brought in for production so that it can be were removed.

Rogers' request was the only one added as a condition

of approval to the permit. The vote of the Council was 4-0, with Council Member Kerri Dorman abstaining after voicing her opposition to the tandem parking spaces and the foul odor which may emanate from the pub during the brewing process, estimated to last for 90 minutes once or twice per week.

In speaking for Platform 8, which will open in the national historic site previously occupied by Pacific Blues Cafe, Chiarello said making an old-fashioned banana split in a vintage building in a high tech way will be fun and that the space will be brought back as a vibrant gathering place.

Council members Marjorie Mohler, Dorman and Vice Mayor Marita Dorenbecher and citizen Pam Reeves voiced their concerns about the large liquid nitrogen tank that will be exposed in an exterior area, open to the public.

Yountville Director Sandra Liston report ed the fire marshal had raised concerns about the placement of the stainless steel liquid nitrogen tank as well and that a building permit cannot be issued for the project until the marsal is satisfied that the planned tank and its installation and placement meet public safety standards.

While the Council considered putting conditions on the tank, Mayor John Dunbar cautioned the Council against trying to do the job of the fire marshal, noting that there will be an in-depth evaulation at the time the building permit is pulled.
