The "1. Sales-Page-Content" folder contains everything you need to get your sales funnel setup and ready to take orders. The second folder inside Sales Page Content contains all of the Video files including voice over script, voice over recordings and the actual videos. Even though you're supposed to NOT use our name, Funnel Art, we understand our logo is part of those videos. YOU DO HAVE PERMISSION TO USE THESE VIDEOS ON YOUR SALES PAGE AS-IS. This is the only area you can use our Funnel Art name.

The third folder inside Sales Page Content contains the graphics we used to create sales page. There is also a logo that you can use if you wish.
