  - Wedding and Reception Cleaning Fee \$140.00

- Setup & Takedown of Fellowship Center Tables - *if needed* list of contacts provided by church office - Payment to be made directly to individual.

Non-Church Families (neither bride nor groom nor either parent is a member of Mt. Pleasant Church)
