**Orlando, FL** — Bridges of America, a system of therapeutic, life-changing communities that provide work-release and transition programs for male and female inmates transferred from Florida's prisons, is partnering with Men's Wearhouse for the fifth annual National Suit Drive, the nation's largest collection of gently used business attire.
