



### **Submission Release for Entry into the NATPE Global Pitch Showcase**

To enter a project ("Project") into the NATPE Global Pitch Showcase, you or your company (referred to going forward as "you" or "your") must be the sole owner of all rights in and to the project (including, but not limited to intellectual property rights), free from any rights from any third party, including (but not limited to) any broadcast or cable network, SVOD platform or distributor; furthermore, you acknowledge that you have freely submitted your Project to the NATPE Global Pitch Showcase for consideration by NATPE, LLC. ("NATPE").

You accept and agree that your Project will be reviewed and discussed amongst employees and/or representatives of each of NATPE and the Participating Experts. This review and discussion will determine your Project's eligibility to be presented at the NATPE Global Pitch Showcase live pitch competition at NATPE Global on February 6, 2025 (the "Live Pitch").

You understand that the Participating Judges and their employers ("Participating Companies") may have, at any time, explored or created materials that are the same or similar to the theme, plot, idea or format of your Project, and that by submitting your Project to the NATPE Global Pitch Showcase, you relinquish any claim to the ideas, in full or in part, as it relates to any current or future programs ~~on~~ of the Participating Companies. By entering a Project into the NATPE Global Pitch Showcase, you waive any and all claims against NATPE and/or the Participating Companies, and you will not be entitled to any compensation from NATPE, nor the Participating Companies, for the execution of this Release or the use of such materials. Further, you hereby (i) release NATPE and the Participating Companies from any and all claims, demands or causes of action which you and/or your heirs, successors or assigns may now have or hereafter acquire with respect to your Project, and (ii) affirm that you have no right whatsoever to any action in equity (including, but not limited to, an action for injunctive relief).

Submission of your Project to the NATPE Global Pitch Showcase does not imply a contractual agreement between you and NATPE, nor the Participating Companies. NATPE and the Participating Companies shall not be under any obligation to you with respect to your Project except as may later be set forth, at the Participating Companies' sole discretion, in a fully

executed written agreement between you and the applicable Participating Company. If selected for the Live Pitch, you agree to present your Project during a timed, five-minute presentation. Any presentation of footage or handing out of materials must fall within the five-minute presentation

As NATPE Global's main conference sessions may be recorded and posted after the event on NATPE's event messaging tool (as of the date hereof, natpeXchange), you agree to provide the release of audio and/or video during your Live Pitch for future viewing by registered NATPE Global 2025 attendees. NATPE and the Participating Companies will not be held responsible for the use of your idea by any third party due to your participation in the live pitch competition at NATPE Global.

You hereby agree that you have read and understand this release, that no oral representations have been made to you, and that this release states our entire understanding regarding your submission.
