DECLARATION RESTRICTIVE COVENANTS FOR ARLINGTON PARKE

Declarant hereby declares that the following restrictions apply to the Property and run with the land:

- 1. No window unit air conditioners will be visible from the street. Satellite dishes may not be installed in any location visible from the street and must be located to the rear of the home.
- 2. No signs containing offensive, obscene, or inflammatory language or imagery will be permitted on any lot. No more than one (1) flagpole will be permitted in the front yard of each lot.
- 3. No improper storage will be permitted, including, but not limited to, laydown basketball hoops, garbage, debris, litter, or other substantially similar items. Burning of trash and garbage is prohibited.
- 4. No unattached garages, carports, coops, cages, house trailers, or manufactured dwellings will be permitted on any lot. Prefabricated, modular, and mobile homes are prohibited.
- 5. All vehicles, including but not limited to cars, boats, and recreational vehicles, will be parked on paved surfaces only. Parking on grass will not be permitted at any time. No inoperable vehicles may be stored on any lot.
