**GRAYSON PLACE VILLAS, 2<sup>ND</sup> PLAT**

**MASTER ASSOCIATION DECLARATION**

THIS DECLARATION, made as of the 31 day of July, 2017, by the Declarant, PRAIRIE HAVEN PARTNERS, LLC, a Kansas limited liability company.

WITNESSETH:

WHEREAS, the Declarant has executed and filed with the Register of Deeds of Johnson County, Kansas, a 2nd Plat of the subdivision known as "Grayson Place Villas", which plat was recorded on July 25, 2017, in Book 201707 at Page 009388; and

WHEREAS, such plat adds the following lots to the community of GRAYSON PLACE, to-wit:

Lots 26 through 49, inclusive, GRAYSON PLACE VILLAS, 2<sup>ND</sup> PLAT, a subdivision in the City of Olathe, Johnson County, Kansas, according to the recorded plat thereof;


WHEREAS, the Declarant, as the owner of the foregoing lots ("Additional Lots") desires to subject the Additional Lots to the covenants, restrictions, easements and other provisions contained in that certain Master Association Declaration, dated as of June 18, 2012 (the "Original Declaration"), executed by Declarant and filed with the Register of Deeds of Johnson County on June 19, 2012 and recorded in Book 201206 at Page 006674.

NOW, THEREFORE, in consideration of the premises, Declarant, for itself, and for its successors and assigns, and for its future grantees, hereby agrees and declares that all of the Additional Lots shall be, and they hereby are, subject to the covenants, restrictions, easements and other provisions set forth in the Original Declaration. As contemplated in the Original Declaration, this instrument shall have the effect of subjecting the Additional Lots to all of the provisions of the Original Declaration as though the Additional Lots had been originally described therein and subjected to the provisions thereof.
