

1. Sales Tax and State-Specific Consumer Notices

BULQ.com is required to collect sales tax in certain states where we have a physical presence, and for those states you will see that amount calculated and added to your purchase at time of check out. BULQ's calculation of sales tax will be based on applicable state and local tax laws but may vary from requirements due to complexities in tax laws. In states where we do not have a physical presence we are not required to collect sales tax, however you may still be responsible to that state for sales tax on your online purchases. For more information about your obligations, visit your state's taxing authority's website. In addition, some states require us to provide you additional information about their requirements at the time of your purchase (see below for residents of AL, CO, KY, LA, OK, PA, RI, VT, WA). Some of those states also require us to provide an annual purchase summary to you at the end of the year, as well as a report to the authority regarding your total purchases which may be taxable. We will endeavor to provide an accurate report, but it may not reflect that you made or received gift purchases.

Notice to Alabama Residents

BULQ.com does not collect Alabama sales or use tax. Alabama sales or use tax may be due in connection with the purchase and delivery of tangible personal property to Alabama individuals and businesses. The purchaser would be required to file a use tax return with the state of Alabama.

Notice to California Residents

California Proposition 65 requires that certain warnings be provided when products contain chemicals known by the State of California to cause cancer, birth defects, or other reproductive harm if the use of those products may cause exposure to those chemicals above specific limits. Notice to Colorado Residents

BULQ.com does not collect Colorado sales or use tax. However, this purchase is not exempt from Colorado sales or use tax merely because it is made over the Internet or by other remote means. Colorado requires purchasers to file sales and/or use tax returns reporting all purchases that are taxable in Colorado and for which no tax was collected by the retailer and to pay tax on those purchases. Because we do not collect Colorado sales tax, we are required to

also provide you a summary of your purchases at the end of the year, and also to provide the Colorado Department of Revenue with an Annual Customer Information Report with your name, address and total spending on BLINQ.com

Notice to Kentucky Residents

BULQ.com does not collect Kentucky sales or use tax. Your purchase is not exempt merely because it is made over the internet. The purchase is subject to Kentucky use tax unless it is specifically exempt from taxation. The state requires that you report any purchase that was not taxed and pay tax on the purchase.

Notice to Louisiana Residents

BULQ.com does not collect Louisiana sales or use tax. Your purchase is not exempt from Louisiana sales or use tax merely because it is made over the Internet. Louisiana requires purchasers to file sales and/or use tax returns reporting all purchases that are taxable in Louisiana and for which no tax was collected by the retailer and to pay tax on those purchases. Because we do not collect sales tax, we are required to also provide you a summary of your purchases at the end of the year, and also to provide Louisiana with an Annual Customer Information Report with your name, address and total spending on BLINQ.com

Notice to Oklahoma Residents

BULQ.com does not collect Oklahoma sales or use tax. Your purchase is not exempt merely because it is made over the internet. The purchase may be subject to Oklahoma use tax unless it is specifically exempt from taxation. The state requires that you report any purchase that was not taxed and pay tax on the purchase and the state requires us to provide you, once a year, with a use tax statement summarizing your purchases for the past year.

Notice to Pennsylvania Residents

BULQ.com does not collect Pennsylvania sales or use tax. Pennsylvania sales or use tax may be due in connection with the purchase and delivery of tangible personal property to Pennsylvania individuals and businesses. The purchaser is required to file a use tax return if tax is due in connection with the purchase and delivery in the Commonwealth. This notice is required pursuant to the provisions of the Tax Reform Code of 1971. 72 P.S. § 7213.2.

Because we do not collect Pennsylvania sales tax, we are required to provide you an end-of-year summary of your purchases to assist you in filing that report. Please note that we are required by law to provide the Pennsylvania Department of Revenue with a report of the total amount of all your purchases from marketplace sellers at the end of the year.

Notice to Rhode Island Residents

BULQ.com does not collect Rhode Island sales or use tax. Your purchase is not exempt merely because it is made over the internet. The purchase is subject to Rhode Island use tax unless it is specifically exempt from taxation. The state requires that you report any purchase that were not taxed and pay tax on the purchase. The tax may be reported and paid on the Rhode Island sales and use tax form which you may be required to file with the state.

Notice to Vermont Residents

BULQ.com does not collect Vermont sales or use tax. Your purchase is not exempt merely because it is made over the internet. The purchase is subject to Vermont use tax unless it is specifically exempt from taxation. The state requires that you report any purchase that was not taxed and pay tax on the purchase. The tax may be reported and paid on the Vermont use tax form and that form and instructions are available on the Vermont Department of Taxes website.

Notice to South Dakota Residents

BULQ.com does not collect South Dakota sales or use tax. Your purchase is not exempt merely because it is made over the internet. The purchase is subject to South Dakota use tax unless it is specifically exempt from taxation. The state requires that you report any purchase that was not taxed and pay tax on the purchase. The tax may be reported and paid on the South Dakota use tax form and that form and instructions are available on the South Dakota Department of Revenue website.

Notice to Washington State Residents

BULQ.com does not collect Washington sales or use tax. Sales or use tax is due on certain purchases delivered or sourced to Washington. Washington requires you to file a use tax return when sales tax is not paid at the time of purchase. This message is required under the Revised Code of Washington 82.13.020(2)(a)(i).
