

## **MINOR Volunteer/Runner Registration Form**

(For Guardian Ad Litem and Parent/Legal Guardian of Participants Under 18 Years of Age)

### **LIABILITY RELEASE, WAIVER, VOLUNTARY ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT**

#### **2026 SPECIAL OLYMPICS FLORIDA LAW ENFORCEMENT TORCH RUN**

In consideration of participating in any capacity in the 2026 Special Olympics Florida Law Enforcement Torch Run, and/or any and all activities preceding and following such event (hereinafter referred to collectively as the "Event"), I (Guardian) represent that I understand the nature of the Event and that the Minor participant is qualified, in good health, and in proper physical condition to participate in such Event. I acknowledge that if I believe the Event conditions are unsafe, I will immediately discontinue the Minor's participation in the Event.

I fully understand the Event involves risks of serious injury, including viral infections, bacterial infections, COVID 19, and other communicable diseases and illnesses, permanent disability, paralysis and death, which may be caused by the Minor's own actions, or inactions, those of others participating in the Event, the conditions in which the Event takes place, or the negligence of the "Releasees" named below; and that there may be other risks either known or not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, cost, and damages I or the Minor participant incur as a result of the Minor's participation in the Event.

I hereby release, discharge, and covenant not to sue Special Olympics, Inc., Special Olympics Florida, Inc., their respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, promoters, suppliers, advertisers, vendors, operators, and, if applicable, owners and lessors of premises on which the Event takes place, (each considered one of the "Releasees" herein) from all liability, claims, demands, losses, or damages on my or the Minor's account caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations; and I further agree that if, despite the release, waiver of liability, and assumption of risk I, or anyone on my behalf, makes claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any loss, liability, damage, or cost which may occur as a result of such claim.

Special Olympics Florida may photograph or otherwise record the Minor while at the Event and all such photographs, video tapes, audio tapes and/or digital recordings of any kind, taken or recorded of the Minor by Special Olympics Florida in connection with Minor's attendance at or participation in the Event, or in connection with any publicity and/or promotional appearances relating thereto, shall be the exclusive property of Special Olympics, Inc. and Special Olympics Florida. Special Olympics Florida and Special Olympics, Inc. may use photographs or other recordings for any legal promotional purpose associated with the Special Olympics. Guardian hereby further agrees to release and discharge Special Olympics Florida, Inc., Special Olympics, Inc., their parents, subsidiaries, insurers, directors, officers, employees, volunteers, agents, successors and assigns (collectively, the "Sponsors") from any claims, actions, damages, demands, costs, expenses (including attorneys' fees) or lawsuits by reason of the sale or use of such photographs or recordings, whether caused by the negligence of the Sponsors or otherwise.

This Waiver and Release is intended to be only as broad and inclusive as permitted by Florida Statute Section 744.301. Any court interpreting this Waiver and Release shall construe the same as being only as broad and inclusive as permitted by such statute.

**NOTICE TO THE MINOR CHILD'S NATURAL GUARDIAN  
READ THIS FORM COMPLETELY AND CAREFULLY. YOU ARE  
AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A  
POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING  
THAT, EVEN IF SPECIAL OLYMPICS FLORIDA, INC., SPECIAL  
OLYMPICS, INC. AND THEIR PARENTS, SUBSIDIARIES,  
INSURERS, DIRECTORS, OFFICERS, EMPLOYEES, VOLUNTEERS,  
AGENTS, SUCCESSORS AND ASSIGNS USE REASONABLE CARE IN  
PROVIDING THIS ACTIVITY, THERE IS A CHANCE YOUR CHILD  
MAY BE SERIOUSLY INJURED OR KILLED BY PARTICIPATING IN  
THIS ACTIVITY BECAUSE THERE ARE CERTAIN DANGERS  
INHERENT IN THE ACTIVITY WHICH CANNOT BE AVOIDED OR  
ELIMINATED. BY SIGNING THIS FORM, YOU ARE GIVING UP  
YOUR CHILD'S RIGHT AND YOUR RIGHT TO RECOVER FROM  
SPECIAL OLYMPICS FLORIDA, INC., SPECIAL OLYMPICS, INC.  
AND THEIR PARENTS, SUBSIDIARIES, INSURERS, DIRECTORS,  
OFFICERS, EMPLOYEES, VOLUNTEERS, AGENTS, SUCCESSORS  
AND ASSIGNS IN A LAWSUIT FOR ANY PERSONAL INJURY,  
INCLUDING DEATH, TO YOUR CHILD OR ANY PROPERTY  
DAMAGE THAT RESULTS FROM THE RISKS THAT ARE A  
NATURAL PART OF THE ACTIVITY. YOU HAVE THE RIGHT TO  
REFUSE TO SIGN THIS FORM, AND SPECIAL OLYMPICS  
FLORIDA, INC. AND SPECIAL OLYMPICS, INC. (AND THEIR  
EMPLOYEES, VOLUNTEERS, AGENTS) HAVE THE RIGHT TO  
REFUSE TO LET YOUR CHILD PARTICIPATE IF YOU DO NOT  
SIGN THIS FORM.**
