IN CONSIDERATION of being permitted to participate in a try out for the Sugar Land Skeeters Baseball Team, and to enter and engage and participate in baseball events on the designated baseball field, hereinafter referred to as Restricted Area, the undersigned, for himself and his personal representatives, assigns heirs, and next of kin, agrees, and on the direct representation that he has or will inspect the designated Restricted Area and that it is safe and reasonably suited for the intended purposes for which the Waiver and Release applies, and now therefore the undersigned:

1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE, the Sugar Land Skeeters Baseball Club, their officials, owners, coaches or team members, used to conduct this try-out event, and each of them, their officers and employees, hereinafter referred to as Releasees, from all liability to the undersigned, whether caused by negligence of releasees or otherwise, while the undersigned is in or on the Restricted Area, and competing, observing, working for or in any way participating in the try-out event; and,
2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS, AND COVENANTS NOT TO SUE the releasees for any loss, liability, damage, or cost they may incur due to the presence of undersigned in or upon the Restricted Area, or in any way, competing, observing or working and trying out, or for any purpose participating in the try-out event, and whether caused by negligence of the releasees or otherwise; and,
3. THE UNDERSIGNED expressly acknowledges and agrees that the activities of the try-out are very dangerous and involve the risk of serious injury and/or death and/or property damage. The undersigned further expressly agrees that the foregoing release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the province or state in which this try-out event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THIS WAIVER AND RELEASE OF LIABILITY AGREEMENT, and further agrees that no oral representation, statements or inducements apart from this foregoing written agreement have been made.
