Off Licence

Section 17 to 20, 64 and 135, Sale and Supply of Alcohol Act 2012



Section 39 of the Act applies to this licence; and the licensee is also authorised to sell alcohol by auction in the course of the licensee's business as an auctioneer.

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **Thornton Auctions Limited** (the licensee) is authorised to sell alcohol by auction in the course of the licensee's business as an auctioneer on the premises situated at **50 Fairfax Avenue Penrose Auckland 1061**, and known as **Thornton Auctions**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

CONDITIONS

This licence is subject to the following conditions:

- (a) No alcohol is to be sold on or delivered from any premises on Good Friday, Easter Sunday, Christmas Day, or before 1pm on Anzac Day.
- (b) Alcohol may be sold only while the licensee is registered as an auctioneer under the Auctioneers Act 2013.
- (c) Alcohol may be sold only during the licensee's business as an auctioneer, and only during the following days and hours:

 Monday to Sunday 10.00am to 9.00pm.
- (d) The licensee must take reasonable steps to verify that the prospective buyer (and any prospective receiver) of any alcohol is not under the purchase age. For internet orders, the licensee takes such reasonable steps if the website has an age verification prompt:
 - (i) once when the prospective buyer first enters the internet site; and
 - (ii) again, immediately before the sale of any alcohol is completed.
- (e) Every receipt or catalogue for the sale of alcohol sold remotely must display:
 - (iii) the licensee's name
 - (iv) the licence number
 - (v) the date on which the licence expires.
- (f) Any website that the licensee uses to sell alcohol remotely must display an image or a link to an image of this licence.
- (g) The whole of the premises is undesignated.
- (h) The licensed premises are more precisely identified as outlined in the plan date stamped as received by Auckland Council on 4 December 2024.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) until the close of the period for which it was last renewed; or
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, until the close of the period of 3 years after the period for which it was last renewed.

This licence expires on the close of 8 December 2027 unless renewed.
